ECS & POP USE AN INTENSIVE, HOME-VISITATION APPROACH WITH PARENTS AS TEACHERS CURRICULUM, TO PROVIDE SUPPORT, SCREENINGS, ADVOCACY AND EDUCATION FOR CHILDREN PRENATALLY THROUGH KINDERGARTEN AND THEIR CAREGIVERS. PARTICIPANTS ARE ALSO CONNECTED TO HEALTH CARE PROVIDERS WITH WELL CHILD CHECKUPS AND ARE ON TRACK WITH IMMUNIZATIONS. 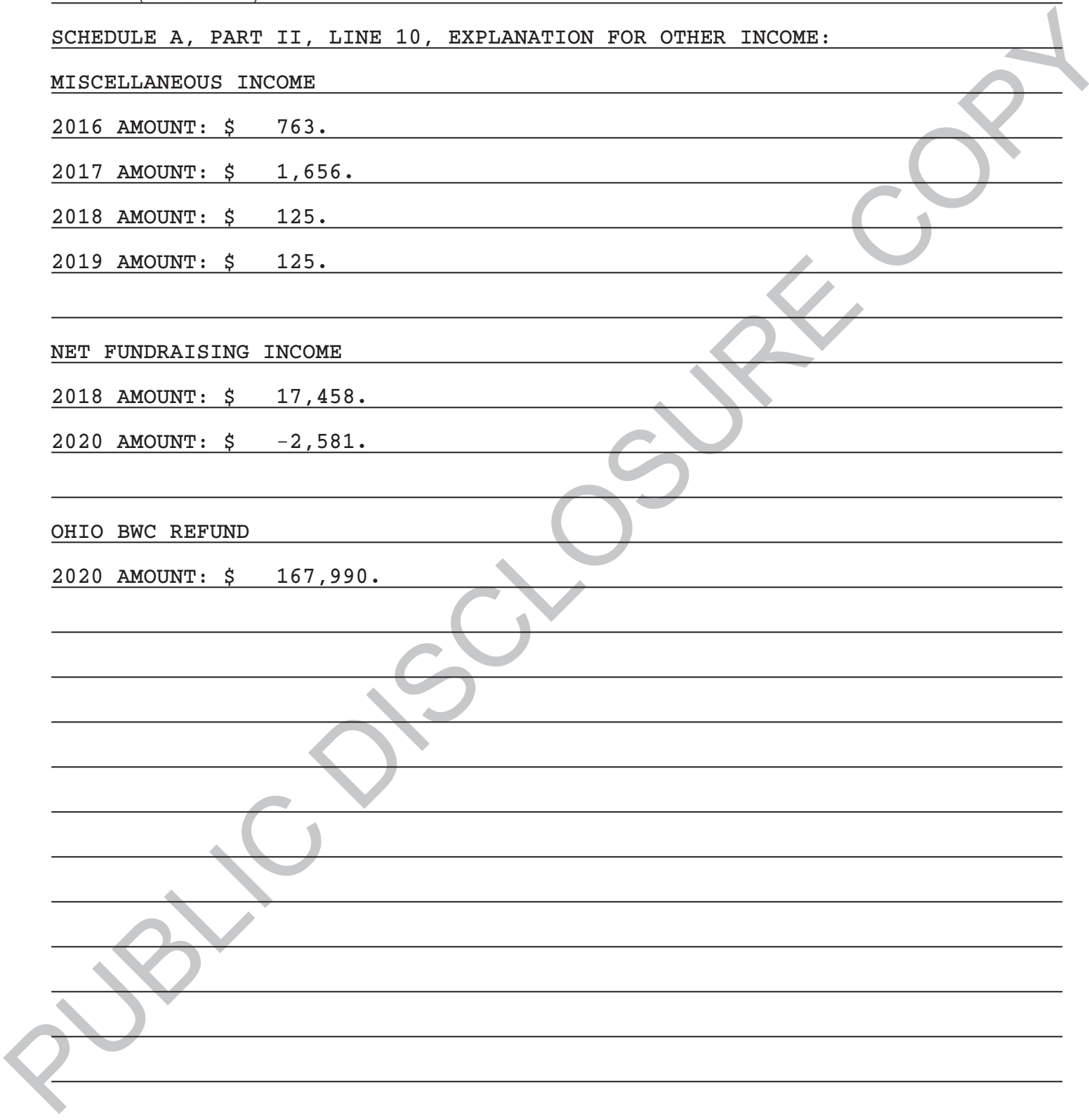

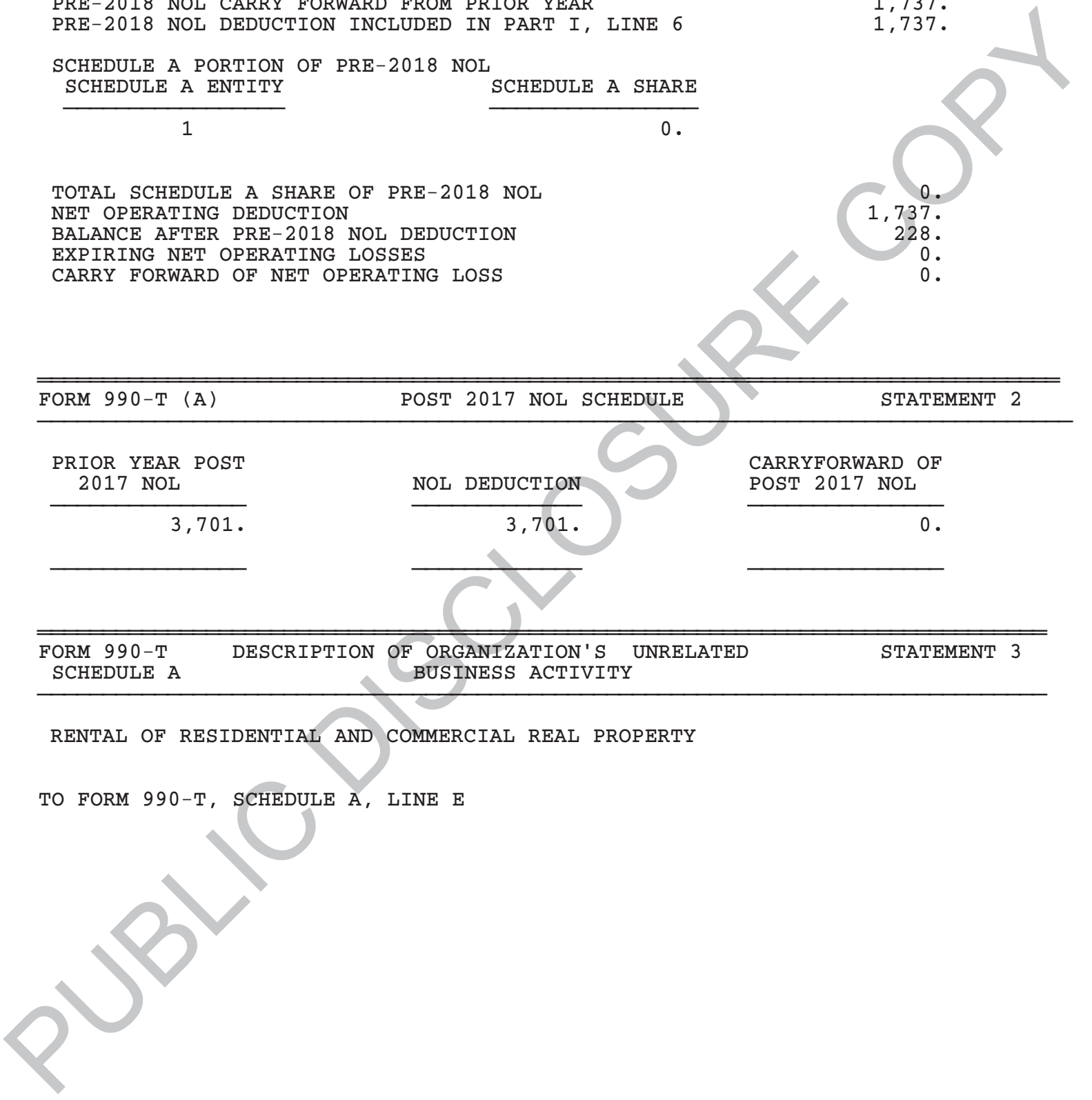
